STATUTORY DECLARATION

SECTION 31 (6) OF THE HIGHWAYS ACT 1980

No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 14th October 1997 referred to in 2. above other than those footpaths marked in purple on the plan accompanying this declaration and at the present time the Trust has no intention of dedicating any more public rights of way over its property.
